

1. Introduction

2. Definitions

User: Any individual whose personal information is collected, received, processed, stored, dealt with, or handled by STPL.

Information: Personal information of a User collected by STPL under this Policy, including:

- Technical Data: IP address, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access our website.
- Usage Data: Information about how you use our website, products, services, and solutions.
- Marketing and communications data: Your preferences in receiving marketing updates from us and your communication preferences.

3. Governing Law

This Privacy Policy is governed by the laws of the Republic of India, including the Indian Information Technology Act, 2000.

4. Applicability

This Policy applies to all Users whose Information is collected, received, processed, stored, dealt with, or handled by STPL.

5. How we use User Information

We use the Information we collect in the ways:

- To provide, operate, and maintain our website and services.
- To improve, personalize, and expand our website and services.
- To understand and analyze how Users use our website and services.
- To develop new products, services, features, and functionality.
- To communicate with Users, either directly or through our partners, including for customer service, updates, and marketing purposes.
- To process Users' transactions and manage orders.
- To send Users emails.

We retain Information only as long as necessary to fulfill the purposes for which it was collected, including legal, business, accounting, or reporting requirements. In some circumstances, we may anonymize Information so that it can no longer be associated with the User, in which case we may use such information without further notice.



6. Sharing your Information

We may share User information with third parties in the following circumstances:

- With service providers who perform services on our behalf.
- With our business partners to offer Users certain products, services, or promotions.
- To comply with legal obligations, protect and defend our rights and property, prevent fraud, and ensure the safety of our Users.

7. Data Security

We use administrative, technical, and physical security measures to help protect Users' personal information. While we have taken reasonable steps to secure the personal information provided to us, please be aware that no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against interception or misuse.

8. Your Data Protection Rights
